  - c. If he or she is adjudged insolvent;

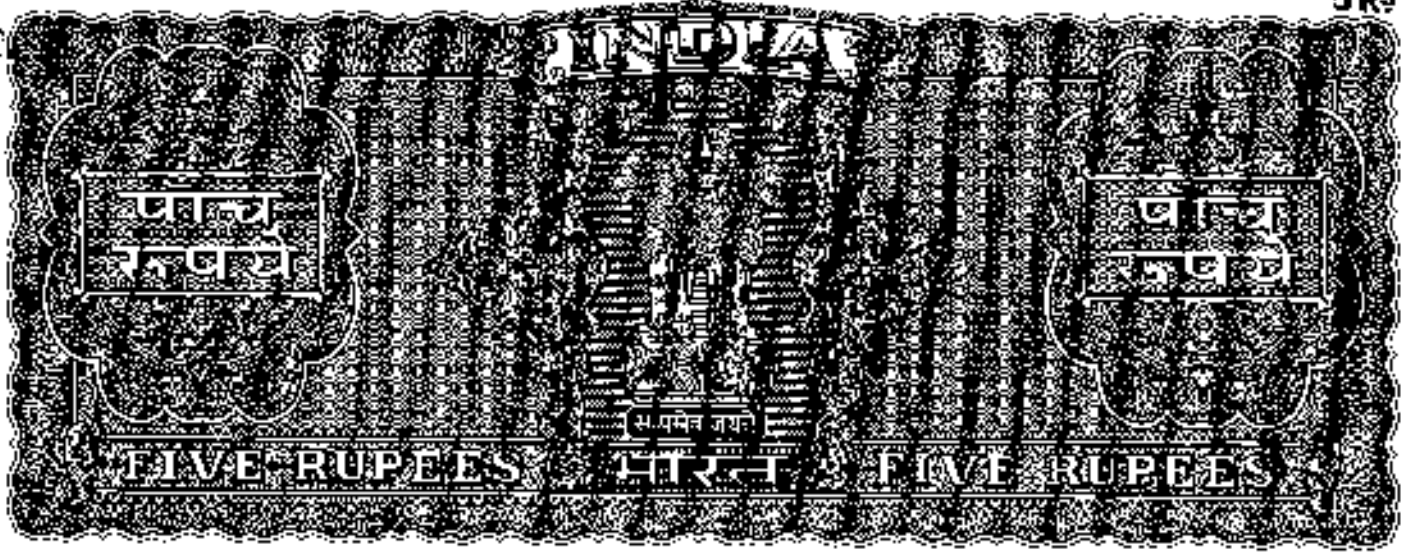

f. If he or she is otherwise disqualified to act according to Law for the time being in force and governing charitable trusts.

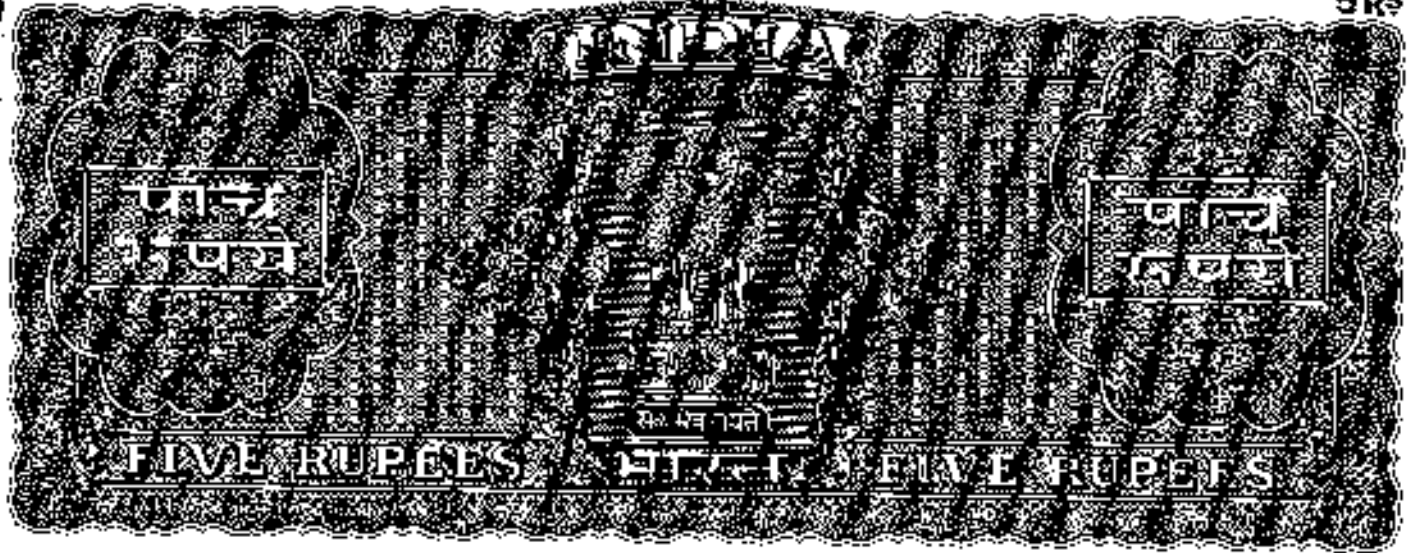

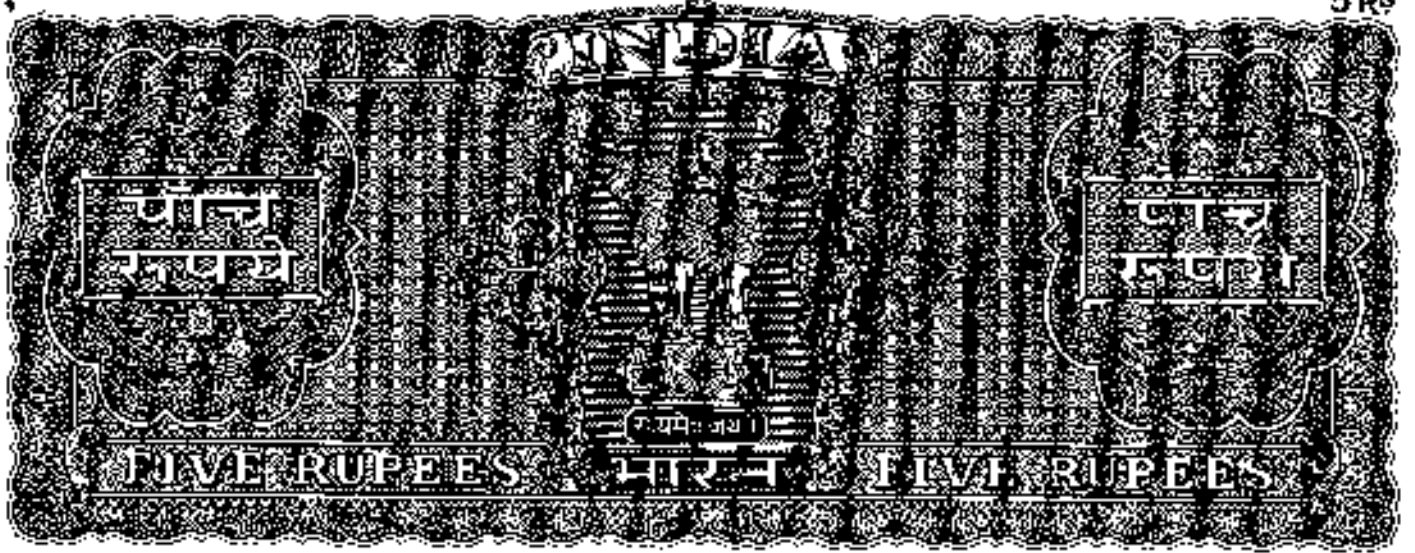
13. The Funds of the trust shall be invested:-

- 14. If, in the opinion of the Board, any property belonging to the trust is deteriorating in value or is not yielding a reasonable income, Board may exchange or sell the said property and acquire any other property or invest the proceeds in the manner herein provided.
- 15. Moneys, other than the capital funds of the trust any at the discretion of the Board, be invested in current accounts with such scheduled banks and post offices, savings banks as may be specified by the Board by means of a resolution passed at a meeting of the Board.
- 16. An investment made in any manner authorised herein shall not be improper by reason only of the fact that anyone or more members of the Board are interested as Directors or share holders in the Bank, company, or corporation in which any of the Trust funds may be invested.

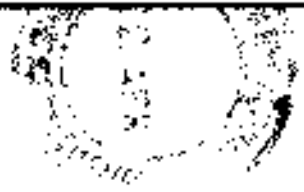

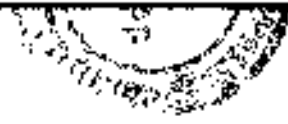

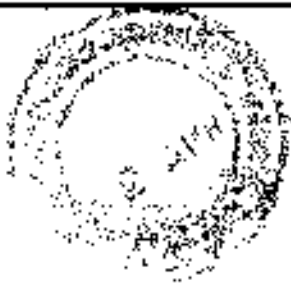
